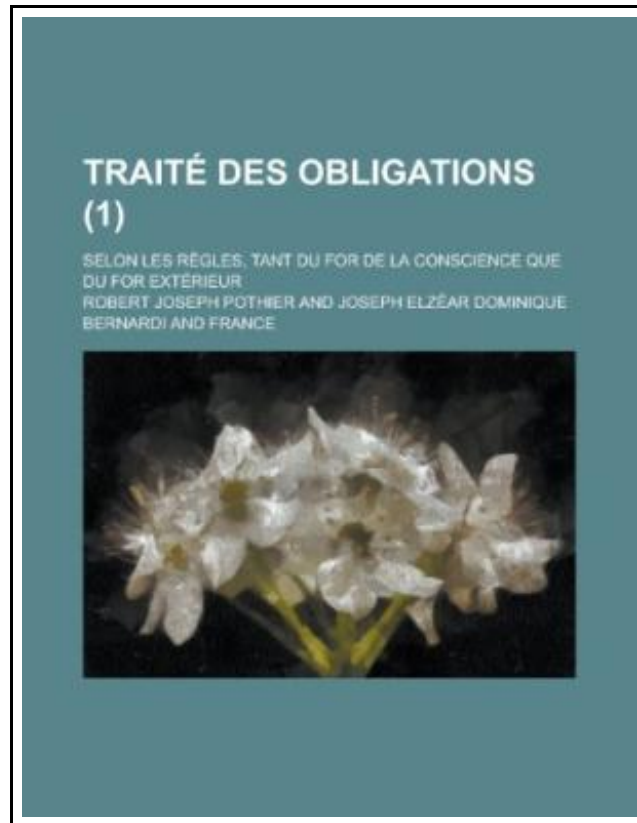

VA contends that the implementation of VCAA notice requirements has significantly contributed to the time it takes to process disability claims. Based on VAs interpretation of notice requirements under VCAA, the processing timeline is extended by 90 days minimum (60 days after receipt of claims and an additional 30 if no response). Nonetheless, as recommended by the VDBC, the Committee supports efforts to further streamline the VCAA notice by possible implementation of an informed consent form when the claim has been fully developed and the veteran is satisfied with the evidence submitted before the 60 - 90 day window. This would likely allow well-developed claims to be adjudicated upon receipt, decreasing processing timeframes. Furthermore, the Committee finds that it is essential that VA develop a detailed checklist to include with its VCAA letters that it sends to veterans. The Committee is absolutely confounded by VAs resistance and reluctance to make this move peremptorily. VA complains of the additional requirements that subsequent Court decisions have mandated. However, the Committee believes that VA has failed to embrace the spirit of the VCAA by not providing veterans with useful information to assist in their claims for benefits. In fact, during a Subcommittee on Disability Assistance and Memorial Affairs hearing conducted on April 10, 2008, William P. Greene, Jr. , Chief Judge, U. S. Court of Appeals for Veterans Claims, stated in response to a question posed by Chairman John J. Hall: In 2000, I thought the message was clear...
